

**ORDINANCE 20-08**

**AN ORDINANCE LEVYING TAXES IN THE VILLAGE OF EAST HAZEL CREST  
COOK COUNTY, ILLINOIS  
YEAR BEGINNING MAY 1, 2020 AND ENDING APRIL 30, 2021**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of East Hazel Crest, Cook County, Illinois:

**SECTION ONE:** That the amount of taxes for the fiscal year commencing the first day of May, 2020 and ending the thirtieth day of April 2021, for all corporate purposes exclusive of the sums or amounts necessary for (1) Street and Bridge Fund; for (2) Police Protection Fund; for (3) Fire Protection Fund; for (4) Collection and Disposal of Garbage; for (5) Payment of Bond Insurance; for (6) Illinois Municipal Retirement Fund; for (7) Municipal Audit; and for (8) Loss and Cost in Collection; to be levied upon all property subject to taxation within the Village of East Hazel Crest, and the same is hereby fixed at SEVEN HUNDRED FORTY THOUSAND FORTY ONE DOLLARS AND FIFTY FOUR CENTS (\$740,041.54) and the sum is hereby accordingly levied upon all property in said Village subject to taxation as aforesaid.

**SECTION TWO:** That the sum of ONE HUNDRE ONE THOUSAND SEVEN HUNDRED SEVENTY DOLLARS AND THIRTEEN CENTS (\$101,770.13) being taxes levied for the fiscal year specified in Section One of the Ordinance, shall, when received, be used for the purpose of paying the following items, each of which an appropriation has been made in and by an Appropriation Ordinance passed by the Trustees of the Village of East Hazel Crest; itemized hereafter in the column headed "Appropriation," and the specific items and amounts herein and hereby levied are listed in the column headed "Levy."


